

**NWA Pride Release and Waiver Liability  
for 2010 NWA Pride Parade**

IN CONSIDERATION of being allowed to participate in the 2010 NWA Pride Parade in a Vehicle and/or Float :

1. I understand and agree that, although I have been supplied with certain information on the prescribed parade route, the nature of the 2010 NWA Pride Parade does not permit me to inspect the prescribed course or any portion of the prescribed course or the immediately adjacent areas thereof with which I may come in contact during the 2010 NWA Pride Parade prior to my participation in the 2010 NWA Pride Parade. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all necessary precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further in the 2010 NWA Pride Parade.
2. I understand that:
  - a. Participation in the 2010 NWA Pride Parade involves RISKS AND DANGERS, as does any roadway vehicular activity, of serious BODILY INJURY, including PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS");
  - b. The SOCIAL AND ECONOMIC LOSSES and or damages which could result from those risks COULD BE SEVERE;
  - c. These risks and dangers may be caused by my own actions, or in-action's, the actions or in-action's of others, the rules of the 2010 NWA Pride Parade; the condition and layout of the prescribed route, or the NEGLIGENCE OF THE "S" NAMED BELOW;
  - d. There may be OTHER RISKS NOT KNOWN TO ME or that are not foreseeable at this time.
3. I ACCEPT SUCH RISKS AND RESPONSIBILITIES FOR THE LOSSES OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS OR DEATH, even if caused in whole or in part, by the NEGLIGENCE OF THE "RELEASEE" NAMED BELOW.
4. I HEREBY RELEASE, DISCHARGE AND COVENANT NOT TO SUE the promoters, participants, officials, vehicle owners, drivers, crew members, rescue personnel, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASEE," FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND IN ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENTS(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
